NEW BUSINESS

Discuss Woods Pool Leak

Pacanowski summarized the detailed report previously distributed outlining the proposal for the remediation for the leak in the gutter system at Woods Pool. In addition to the proposal for the repair of the leak, a 2024 Budget for Woods Pool Funds Operations and a history of water rates and gallons utilized at the pool was distributed and summarized.

Pacanowski recommended that a meter be placed on the valve in order to monitor how much water is being lost due to the leak and how much water is being used for normal pool maintenance and operations, i.e., showers, deck cleaning, etc.

Caplis asked if the pool heater is gas.

Pacanowski responded that they are.

Quigley stated that the choice is then to either fix the pool gutter system for \$132,000 or make no repairs which will cost an approximate \$2,800 in additional water bills for water loss for the season.

Caplis stated that the amount of water lost will fluctuate dependent on weather and rainfall.

Caplis asked how often water is added to the pool.

Pacanowski stated that water is added every day as water needs to be up to the lip of the gutter system in order to keep the filter system going.

Caplis introduced Joe Gianmanco, 1309 Laurie Lane, Burr Ridge, who used to maintain Woods Pool prior to the Burr Ridge Park District's acquisition of the pool.

Mr. Gianmanco stated that his background is in Engineering and he took care of all aspects of the pool including rebuilding the filter system prior to the Burr Ridge Park District's purchase of the pool. He asked if the company that gave the estimate for repair of the gutter system looked for the leak with a scope.

Pacanowski responded that he was not certain but believes a scope was used in addition to dye.

Mr. Gianmanco asked if the cracks in the gutter were in the upper area of the gutter or lower.

Pacanowski responded that he believes approximately 50% of the leaks in the gutter system were in the upper portion of the gutter or at the midway point and up.

Mr. Gianmanco suggested that perhaps instead of ripping the top of the gutter off, they can apply a sealant by hand and save a significant amount of money. They will not be able to reach 100 percent of the gutter areas, however, a significant portion will be able to be sealed which will reduce the amount of water lost. This is not a perfect solution; however, it should work. This will prevent having to rip the entire top of the gutter system off and incur the \$132,000 repair bill.

Pacanowski stated that there are a limited number of pool companies that will perform this type of repair.

Mr. Gianmanco added that it is somewhat helpful that there is a higher turnover of water with the leaks as it is more sanitary with that a high turnover of water and allows for less use of chemicals.

Pacanowski stated that an analysis of chemical use vs. cost of water was not performed, however, chemical supplies were \$7,500 this season.

Caplis asked if there is a diagram showing the leaks found.

Pacanowski will see what can be produced by the leak investigators.

Caplis stated that if half of the leaks can be reached by hand and sealed it would be beneficial to perform that to prevent at least some of the water loss.

Pacanowski stated that he will pull information together regarding the location of the leaks, however, time is of the essence.

Caplis stated that there is no doubt the pool will be opening in 2025, however, some research is needed in order to see if a smaller fix, as opposed to the \$132,000 estimate for a complete gutter repair, is possible.

Caplis asked how much the repair will cost at the kiddie pool. Pacanowski responded that it will be approximately \$500.00

Caplis asked if a land line is absolutely necessary at the pool as opposed to a cell phone. Pacanowski responded that discussion regarding the necessity of the land line should be tabled until next month for input from Jamie Janusz.

Caplis stated that the pool bathrooms were not always open for Aquacize class and when they were open, they were not clean. In addition, the pool was green on one occasion. Pacanowski responded that he will check into it and get back to the Board.
